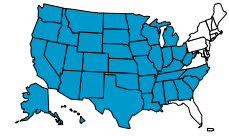

If multiple rebate submissions are received, the first submission will be processed and all others will be denied. No exceptions.
- Retail purchase receipts should clearly indicate order date, quantity and a description of the Hunter Douglas products purchased. A good description is "2 Silhouette window shadings with UltraGlide, A1-125 Radiant White". A bad description is "2 white shades".
- The Hunter Douglas rebate fulfillment center enters all rebate submissions based on the order date listed on the retail purchase receipt. Dealers should be reminded that the date on the receipt should be the date that the dealer sold the product(s) to the consumer and not the date of the installation or when the products shipped to the consumer.
