The Company hereby authorizes the bank and business references listed above to release any information necessary to assist Kaleidoscope in establishing a line of credit. Kaleidoscope must be notified of any changes in the legal status of the business entity within the time specified by applicable law but in any event not later than 30 days after the change. In the absence of such notification, Kaleidoscope reserves the right to treat the business entity as that shown on this application under applicable laws. The Company also understands that it will be required to update this application from time to time, at the discretion of Kaleidoscope's credit department. In the event that Kaleidoscope or its assignee has to file suit to collection money due, the Company agrees that venue of any such legal action commenced for the purpose of recovery may be laid in the county in which the complainant has the principle place of business, at the option of Kaleidoscope, and that the service of process may be effected by mailing a copy of the complaint via first class mail, postage pre-paid, to the Company's last known business address and that any right to further or superior notice is hereby waived. The Company shall pay reasonable attorney's fee and other costs incurred in connection with any such collection efforts. The Company agrees that Kaleidoscope will not be liable for mistakes in order specification when the order was placed by phone, or for costs incurred by failure to inspect goods upon receipt.

If the Company is a corporation, the undersigned individual, being a shareholder and/or officer of the company, does hereby personally guarantee the prompt and complete performance by the Company of all obligations (including but not limited to the payment of money) due from the Company to Kaleidoscope at any time.
